

NZC Terms and Conditions

1. Instructions, prizes and information on how to enter form part of these conditions of entry. By entering, entrants accept these conditions of entry.

2. The promoter is New Zealand Cricket, 8 Nugent Street, Grafton, Auckland 1023.

3. The promotional period begins at 8am, Tuesday 17 November 2020 and ends at 6pm, 27 November 2020.

4. Entries are open to all residents of New Zealand, excluding employees of New Zealand Cricket, their immediate families or any agents including other advertising, marketing or promotional firms associated with this competition.

5. The prize is a cricket experience for two, including flights and accommodation for a match of the winner's choice in New Zealand in 2021 from the 2020-21 home international cricket schedule. The prize is not transferable or exchangeable and cannot be taken as cash. The Promoter reserves the right to change the prize to one of the same or equal value at any time if the prize becomes unavailable.

6. To enter, use the code provided in the competition email and purchase a ticket at www.ticketek.co.nz/cricket before the first ball of the BLACKCAPS v West Indies match on 27 November 2020. Use of the code will sign you up to Cricket Nation and each transaction from that membership will be counted as an entry. Note – there is a limit of 19 tickets per transaction when using the code, however you can make more than 1 transaction. The winner will be the first entry drawn at random from all valid competition entries received.

7. The draw will take place at Monday 30 November at 8 Nugent Street, Grafton, Auckland 1023.

8. The winner will be notified by email or phone, with details of the prize. If the winner cannot take the prize as stipulated or if it is unclaimed within a period of 72 hours, the entry will be deemed invalid and the Promoter reserves the right to award the prize to the next valid entry. In the event of a dispute of the identity of the drawn winner, the winner will be the person named in the purchase of tickets.

9. In the event that the winner is unable to be contacted, and all methods of communication are unsuccessful, the prize remains the property of the Promoter until claimed by the winner. The Promoter may conduct such further draws as are necessary in order to distribute any unclaimed prizes.
