### **How to win**

2. The Promotion commences at 12:00 PM on the 2<sup>nd</sup> November 2018, and concludes at 11hrs 59mins PM on Saturday 16<sup>th</sup> February 2019, the day prior to the Burger King Super Smash Grand Final (the Promotion Period). No entries will be accepted outside of the Promotion Period.

Entry into the Promotion is granted only by making an online purchase via [www.ticketek.co.nz](http://www.ticketek.co.nz) for a match\* in the Burger King Super Smash 2018/19 tournament, and opting in to receiving emails from the Promoter. There is no restriction on the number of times you may enter the Promotion.
4. Purchasing a Burger King Super Smash membership instantly earns you an entry into the weekly prize draw and grand prize draw. No other prizes will be received in this instance.
